



Regulations for the streaming of the Future Builders conference and Building of the Year Created with ALUPROF Systems awards ceremony

General information

By registering your participation in the events connected with ALUPROF SA's Future Builders and Building of the Year Created with ALUPROF Systems initiative, you are consenting to the processing of your personal data by ALUPROF SA, ul. Warszawska 153, 43-300 Bielsko-Biała, Poland (National Court Register No. 0000106225, REGON [National Official Business Register No.] 070424429, NIP [Tax ID No.] 5470242884), tel.: +48 (33) 819 53 00, fax: +48 33 822 05 12, e mail: aluprof@aluprof.eu for the purpose of:

registering you for the event in question, whether online or in person at the venue, which is also tantamount to consenting to receive related information, such as the link to the conference and/or awards ceremony or notification of eventual changes to event starting times, sent, in particular to the e-mail address provided.

PLEASE NOTE: You have the right to withdraw your consent at any time, which will not affect the lawfulness of processing based on the consent before its withdrawal.

Providing your data is essential to your participation in the events. Not providing them will make it impossible for you to attend.

ALUPROF SA will process the personal data you provide on the basis of Article 6 item 1 (a), namely, consent, of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons

with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation; GDPR).

The provision of personal data is a voluntary contractual condition. Not providing the data will make it impossible to register for the events associated with the Future Builders and Building of the Year Created with ALUPROF Systems initiative.

Your data will not be transferred to any third country or international organisation, not will they be used for any purposes other than those connected with the conference and/or awards ceremony.

Who will have access to your data and for what purpose?

The data you provide will be used for verification, in particular as regards their correctness and your wish to take part in a given event, and in order for you to receive notifications about the event in question. We need additional data in the form of your first name and surname in order to verify your identity for the purpose of participating in a given event.

The data you provide will be disclosed as follows:

- a. to authorised staff members/associates of ALUPROF SA, our external IT services provider, solely for the purpose of maintaining the system, external companies providing support in organising the https://future-builders.com/en/contest initiative and the external provider of mailing and hotel services, namely, the entity running the venue where the conference is being held. Your personal data may also be disclosed to the competent authorities, inasmuch as they are thus empowered by the applicable law;
- b. in addition, where appropriate, your data may also be disclosed to external legal services, auditors and ALUPROF SA's Data Protection Inspector.

The data processing period

We will process your data while we are running the conference and/or awards ceremony and until such time as:

- a. you withdraw your consent by sending a notification requesting the withdrawal of consent to resignation@aluprof.eu or by phoning ALUPROF SA;
- b. we are informed that the data we are storing is out of date or inaccurate;

c. three years have passed since the end of the conference/awards ceremony.

In addition, information relating to your withdrawal of consent, together with the relevant data, may be stored for another three years for evidentiary purposes. During that period, the data will be used solely for archival purposes, pending possible claims.

Your rights

You have the right to request ALUPROF SA to provide you with access to your personal data, to rectify them, erase them or limit their processing. You also have the right to object to them being processed and the right to transfer your data and obtain copies of them. To this end, please send your request to aluprof@aluprof.eu.

Please note: some of the rights referred to in the foregoing may be limited in application, depending on the context of the processing.

Your data will not be used for profiling within the meaning of Article 22 of the GDPR. This means that your data will not be subject to automated use to assess certain of your personal factors.

You also have the right to file a complaint with the supervisory body, the President of the Office for Personal Data Protection (www.uodo.gov.pl/en). At the same time, we would like to inform you that your personal data will not be transferred to any international organisation.
